SNF Transitions Pharmacy Provider in Less Than 24 Hours Through Collaboration and Meticulous Project Management

When Time is of the Essence

Once it was determined that the current relationship could no longer be sustained — and with a midnight cutoff of pharmacy services looming — Forum officials spent the day working with Libertyville Manor leadership to negotiate a contract, identify preferred service parameters, and implement the transition. To prevent any lapses in care, the first medication orders were dispensed within 9–12 hours of the facility's initial, verbal commitment. "Within 24 hours, Forum was operating in our facility. Forum made the entire conversion from our existing pharmacy vendor and accomplished it without a single error," said Milan Stokovich, Libertyville Manor Assistant Administrator and co-owner.

Switching long-term care pharmacy providers is not unusual, but accomplishing a full transition and onboarding in less than 24 hours is a result of meticulous project management and in-sync collaboration. As a result of the efficient transition, Libertyville Manor staff members were able to provide seamless care to all residents.

"A Forum pharmacist shared that the organization assembled a special team that worked long hours into the night to complete the conversion, without any additional cost or contract demands to our facility," said Stokovich. "These conversions normally take months, with multiple trial runs and reviews for errors. Forum's ingenuity, talented team members, and dedication made it happen, and it was amazing."
